Summary of Authority to Purchase and Transport Scrap Radiographic Film, Scrap Lithographic Film, Scrap Photographic Film, Scrap Aluminum Plates, Unrefined Silver Flake, and Metallic Replacement Cells.

1. The State Corporation Commission of the State of Kansas, Docket Number 140451M, Permit Number P280667 was granted February 3, 1984 to N. T. And H. Enterprises, Inc., 609 McNair Street, Halstead, Kansas 67056, and amended January 1, 1999. It reads: Private Carrier Permit to Transport their property are granted applicants, dealers in scrap radiographic film, scrap lithographic film, scrap photographic film, scrap aluminum plates, unrefined silver flake.

March 6, 1984 AMENDED TO INCLUDE:
"Silver Recovery Cannisters, electrolytic silver recovery units, plumbing, tubing, fittings, and all necessary repair parts, installation materials, and tools to install and repair cannisters and units, and barrels to transport the film."

2. A properly accomplished U.S. Department of Transportation, Federal Highway Administration, Description of Motor Carrier Operations, Form MCS-1378 has been forwarded by N. T. And H. Enterprises, Inc. to the proper Department with the following information listed:

Item #8. What cargos are transported? Scrap radiographic film, scrap lithographic film, scrap photographic film, scrap aluminum plates, unrefined silver flake, and disposable recovery cells.

Item #9. List States in or through which your Company operates. Arkansas, Iowa, Kansas, Missouri, Nebraska, Oklahoma, South Dakota, and Texas.

3. N. T. And H. Enterprises, Inc. has been issued the following by the Federal Highway Administration Office of Motor Carrier Safety, 3300 South Topeka Boulevard, Suite 1, Topeka, Kansas 66611-2237, Telephone Number (785)267-7288

4. Each year, N. T. And H. Enterprises, Inc. is required to renew licensing with the Kansas Corporation Commission. Proof of liability insurance is required to obtain the license. We must have the K.C.C. License to qualify for the USDOT number.

5. N. T. And H. Enterprises, Inc. does not process the film and flake for the silver content. We purchase film and flake as brokers and sell the materials to a U.S. E.P.A. registered Recycler for final reclamation of the film and flake for the silver content and for the recycling of the P.E.T. film base. All paper folders, reports, etc. are transported to a Recycler and are recycled into insulation, composition shingles, etc. No Materials Are Landfilled.
